Location: George Di Ciero City & County Building / One DesCombes Drive / Broomfield, CO

Eligibility: Open to all artists 18 and older living in Colorado

Mediums: 2-dimensional artwork and photography

Size: Total area of image excluding framing **MUST NOT EXCEED 36 INCHES** (5x7, 6x6 etc.).

Judge: Martin Lambuth - Martin has been juried into local, regional and national shows in CO, WY, CA, ID, and MT. He studied under several local and national art luminaries. His work is in the permanent collection of the Cheyenne Depot Museum, JAMS Denver, Three Tree Capital, the Children's Hospital in Denver and Parker, Kaiser Permanente in Castle Rock and Loveland. Rules: Two-dimensional art work must be original, not copied from any copyrighted material or photograph. Artwork may not have been done under supervision such as in a workshop. No nudes will be accepted. All works must be properly wired and framed. Gallery wrap is acceptable as a continuation of the painting or a decorative edge such as black. No saw tooth hangers will be accepted. All work must be clean. Entries will be inspected for acceptance before being hung for judging. The Broomfield Art Guild reserves the right to refuse art work not complying with the rules or inappropriate content unsuitable to hang in a public building.

Sales: A 10% commission will be collected on all sales. All work accepted will remain for the duration of the show. All works must be for sale. Please price your art to include the 10%. If a sale occurs, the Guild will add 8.25% sales tax to total price of painting.

Entry fees: **\$30** up to 3 pieces of artwork or photographs **\$25** for Broomfield Arts Guild members

Awards: Over \$1000 in cash including a Purchase Award for the City and County of Broomfield, not to exceed \$200.

The Broomfield Art Guild reserves the right to reproduce images of accepted works for publicity only. All insurance is the responsibility of the artist. Utmost care will be taken when handling the paintings, however, neither Broomfield Art Guild nor the City and County of Broomfield will be responsible for any damage or loss of works submitted.
